- **e. New Audit System 2017/18** Details of a new audit system had been received in that a company to procure audit services on behalf of local councils had been set up and that at this stage no further action was required.

121 – 15/16 PLANNING

- a. Reply from Trees Officer, WLDC re tree growing on land of proposed traveller site An amenity assessment on a semi-mature sycamore in the field on the north side of Wragby Road East had been carried out but it had been found not to meet the criteria for a TPO. It was noted that it may score higher in the future and meet the criteria if it became more prominent by the frontage hedge being cut and some of the small scrubby trees and bushes around it being removed to enable it to be more clearly seen from the A158.
- **b. Lincolnshire Minerals and Waste Local Plan** County Councillor Ian Fleetwood had sent a report in that there were no proposals for any sand and gravel extraction with the parish, the nearest sites identified for waste being on Outer Circle Drive and the Allenby Trading Estate in Lincoln.
- **c. Application 133719** Land to the rear of 58 and 60 Wragby Road East outline application to erect 3 dwellings Comments forwarded to WLDC as follows:-

'Of the six members of Greetwell Parish Council who have viewed this application there is unanimous objection to the proposal as follows:-

- A. It is considered that the proposed access to the site would not support three dwellings.
- B. This proposal is on the opposite side of the road to the proposed traveller's site which has received numerous objections from residents due to access on to the busy A158 road.
- C. Objections received from residents regarding the proposed Travellers site have also stated that the area is prone to flooding during heavy rain. Having additional dwellings would also, it is assumed, cause an additional problem regarding the lack of opportunity for soak-away and cause an increase in the occurrence of flooding.'

d. Application 133692 – Wesley Road, Cherry Willingham – outline application for residential development – Members considered this was not for Greetwell Parish Council to comment upon, it not being within Greetwell parish.
