**1 -15/16 POLICE MATTERS**

No Police Report received.

Nomination for members to Police Community Panel – There had been no nominations for the Panel.

**2 – 15/16 NOTES OF MEETING HELD ON 9<sup>TH</sup> MARCH 2015**

Proposed by Councillor Tony Melrose, seconded by Councillor David Hennell that the notes be signed as a correct record.

**3 – 15/16 COUNTY COUNCILLORS REPORT**

County Councillor Mrs Jackie Brockway re-iterated her comments made in the Parish meeting in that the County Council budget's requirement was £65million with only £40 million available.

She reported that she had toured her Ward with Richard Davies, Portfolio Holder for Highways who had said that the second side of Westfield Drive could not be re-surface due to the financial implications, stressing that many footways in the county were in a worse condition.

Mr Davies had stated that highways issues/road damage must continue to be reported.

**4 – 15/16 CORRESPONDENCE AND REPORTS**

**A) Community Speed Watch** – The Chair thanked Councillor John Taylor for erecting the passive signs on the A158, supplied by the Lincolnshire Road Safety Partnership.

**B) Open Gardens Event** - The Chair reported that seven residents had offered their gardens for the event.

The Chair requested approval for a sub-committee to be formed comprising Councillors and residents in order to make arrangements for the event and then report back to the Parish Council at meetings. Both she and Councillor Tony Melrose offered to be members of the Committee.

Proposed by Councillor Chris Thatcher, seconded by Councillor Mrs Sarah Bates that a committee be formed as above.

The Chair also stated that a resident had compiled a quiz for the event and requested that a small prize be given. It was suggested in the first instance that a request be made to Scothern Nurseries. The Clerk would write to them.

Discussion took place as to whom the proceeds of the event should be donated to. Proposed by Councillor John Taylor, seconded by Councillor Chris Thatcher that the proceeds be equally shared between the Lincolnshire Emergency Blood Bike Service and the Lincolnshire and Nottinghamshire Air Ambulance.

- C) Elections 2015** – It was noted that only six nominations had been received by WLDC, all being present members. The Chair thanked Councillor David Hennell for his work on the Parish Council during the time he had been a member. Neighbourhood Plan – Councillor Mrs Sarah Bates reported that she had been in contact with Community Lincs and had been informed that there would be payment required for assistance with the Plan. However in the first instance a survey should be circulated to all residents to ascertain their comments on whether they felt that a Neighbourhood Plan for Greetwell should be compiled.

Proposed by Councillors Mrs Rosemary Seal, seconded by Councillor Chris Thatcher and **Resolved** that an incentive draw take place of returned questionnaires and that £20 be allocated for the first questionnaire drawn.

- D) Get Together – 8<sup>th</sup> April 2015** – This had again been successful. The Chair had asked residents attending if they agreed with contributing £1 at future Get Togethers to try to offset some of the cost. There did not appear to have been any objections. The Chair did ask that if anyone knew of speakers could they please let her know.
- E) Litter Pick – 11<sup>th</sup> April 2015** – Councillor Mrs Sarah Bates reported that 8 persons had collected 20 bags of rubbish.
- F) Letter from Veolia ES UK Ltd** – Advisory letter received that with effect from 1<sup>st</sup> April 2015 Veolia's grounds maintenance business would be transferred to Glendale Ltd.

### **A Applications**

i) Land at Westfield Drive, North Greetwell – 132689 – outline application for residential development – access to be considered and not reserved for subsequent applications

Majority comments - 'Greetwell Parish Council objects to the above application as it is considered generally that the vehicle access is too close to the corner of Westfield Drive/Westfield Approach. This corner is a completely blind bend and will likely cause a traffic hazard.'

Proposed by Councillor Sarah Bates seconded by Councillor Rosemary Seal and **Resolved** that the above comments be conveyed to WLDC.

ii) 88 Wragby Road East, North Greetwell – 132361 – Application to erect extension detached double garage and boundary fencing – Unanimously Resolved that comments to WLDC Planning be 'No objections'.

iii) 48 Wragby Road East, North Greetwell – 132728 – application for proposed extension to rear and recladding in brickwork of existing property – Unanimously Resolved that comments to WLDC Planning be 'No objections'.

**B Planning Appeal** – Land at 54 Wragby Road East, North Greetwell – 132123 – Outline application to erect 1 dwelling with access, appearance, layout and scale to be considered.
