- c) **Compulsory Purchase of land at The Chase by LCC** – Account received for valuation work by Banks Long & Co in the sum of £750.00. This had been forwarded to the Parish Council solicitors for payment.
- d) **The Chase – notification of works adjoining The Chase** – Galliford Try had sent notification that a retaining wall would be erected close to the timber fence boundary of The Chase play area. Assurances has been received from Galliford Try that all works would be re-instated upon completion, planting and landscaping as part of the 'making good' would be programmed and tied in with other works in the area during the next few months
