- b) **Works by Anglian Water – update** – It was noted that reinstatement had now been carried out and the agents for Anglian Water were seeking confirmation that the Parish Council were satisfied with the condition of the reinstatement. That the Chairman inspect the site on behalf of the Parish Council **Resolved** unanimously.

**Application 138635 – Request for a scoping opinion for proposed development of a 55km potable water pipeline from Lincoln to Grantham with associated infrastructure including partially buried 20-million litre bulk potable water storage tank, 3km connecting pipeline to Anglian Water (AWS) site at Bracebridge Heath ('Bracebridge Spur'), connecting sections of pipeline to the existing Central Lincs Trunk Main, partially buried 3-million litre break tank and the erection of 3 pumping stations (the 'Grantham Resilience Pipeline Project') -**

**LOCATION: Long Leys Road, Lincoln to AWS site at Harrowby, East of Grantham (within the Lincoln City Council, West Lindsey District Council, & South Kesteven District Council administrative boundaries)**

That comments by Parish Council to be forwarded to WLDC be 'Anglian Water should be working with Persimmon Homes and the bypass contractors in order to minimise disruption to residents' Unanimously **Resolved**.

The Department for Transport has revealed Lincolnshire's share of the £420 million of roads funding announced in the Budget. Within the East Midlands, Lincolnshire was given the biggest funding boost, netting almost a third of the money granted to the region.

Last year's nightmare winter and the long-hot summer have both taken their toll on the roads, and this £13.7m will help us undo some of the damage over the 5,500 miles of road to maintain.
