# <u>149 – 15/16 FOOTPATHS IN PARISH AND REPORT OF FALL BY RESIDENT DUE TO THE POOR SURFACE OF FOOTPATH ON WRAGBY ROAD EAST</u>

A report was made of a resident falling on an uneven surface of footpath, causing him to break his wrist.

Reports had been made to the LCC Highways and via County Councillor Mrs Jackie Brockway and District Councillor Anne Welburn which had brought negative results.

It was suggested that the matter be referred to the Director of Highways, Mr Richard Wills. The Clerk was therefore instructed to write to him regarding the Parish Council's concern.

It was reported that there were several residents in the parish that were ill or infirm and could use some additional assistance with shopping etc. The Clerk was asked to include this as an item in a future newsletter.

## 152 - 15/16 SPRING LITTER PICK - 'CLEAN FOR THE QUEEN'

It was noted that the Parish Council insurers had issued guidance on Litter Picks (circulated to all members) and advised that a Risk Assessment should be carried out together with a list of those participating. The Clerk would arrange a Risk Assessment form to be drawn up.

Some residents on Wragby Road East had kindly offered to provide refreshments for those taking part in the Litter Pick.

#### 153 – 15/16 GREETWELL PRODUCE SHOW

Councillor Mrs Sarah Bates informed members that she would be prepared to hold the event at her home on Sunday 14<sup>th</sup> August 2016. Items discussed as follows:-

- b) Cherry Willingham Community Group had offered its gazebo for use at a cost of £25; Langworth Memorial Hall had offered their marquee at a cost of £175.00.
- c) Funding for the event was required. The Clerk would investigate this and report back to the April meeting of the Council.
- d) Councillors Mrs Sarah Bates, Tony Melrose, Mrs Rosemary Seal and Mike Taylor would meet to discuss further arrangements and report back to the April meeting of the Parish Council.

a) Retrospective confirmation of Councillor Mrs Rosemary Seal's attendance at Central Lincolnshire Local Plan meeting on 14<sup>th</sup> March 2016 – Members had agreed unanimously since the last meeting of the Parish Council by email that Councillor Mrs Rosemary Seal attend the meeting and ask the following question:-

'If the travellers plan is removed from the local plan can we have an assurance it will not be reinstated in the future?'

Councillor Mrs Seal had attended the meeting and spoken on behalf of the Parish Council and received the following reply:-

'Officers are not recommending this site be allocated, however it will be for an Independent Inspector to determine whether the site should be reinstated - therefore the committee cannot give an absolute guarantee either way on whether the final adopted plan will or will not include this site. We hope the Inspector will respect the decision this committee makes.'

- Application 134042 52 Wragby Road East application for dropped kerb to allow vehicle access to front of property and car parking – Members present at the meeting had no objections to this application.
- c) Application 134075 St Barnabas Hospice, Hawthorn Road Overspill car park using 'grasscrete' or similar at north eastern corner of the site – Members present at the meeting had no objections to this application.
